Paul Carmody recommended Kevin Klauck, Harry Mertz and David Cunnard be reappointed for the Zoning Hearing Board, all voted in favor.

Mayor Orbison, Council and all in attendance thanked Robert Brown for his 14 years of service.

President Carmody took over control for the Council Meeting.

Mrs. Autry informed Council that there is some land available across from School Street that may be usable for the needed Park land.
