**Minutes:** The December 12, 2022 minutes were reviewed. Greg Joyce made a motion to accept the minutes and Cathy Cunnard seconded the motion. No discussion held; all were in favor – motion passed.

**Treasurer's Report:** Connie Klauck read aloud the Treasurer's Report for December 2022 to the members of Council. Cathy Cunnard made a motion to approve the reports and Greg Joyce seconded the motion. No discussion held; all were in favor – motion passed.

Toni Autry expressed concern about the speed vehicles are traveling from RT 65 at the top of the viaduct. Curtis Reiner will submit another ticket to Penn DOT on the issue.
